Thank you Corrine for hosting and providing the soup. Ute liked the salad a lot. Laura F. made a motion to approve the minutes from the August meeting, Ute seconded.

Presidents Report: No report but reserve the right to think of things.

Vice President's Report: No new memberships, currently no one is on the waitlist but we do not know if we will have any openings beyond the 14 horses we have in the pasture currently.

Pasture: The pasture is dwindling. We have an exciting work day planned, 8:30am Saturday AM to demolish the food booth. Bring gloves and be ready to lift debris in trucks. Chipper party date is to be set still.

Treasurer: 12,882.32; minimal activity other than the insurance bill which was 2068.00. This is our annual liability policy. 28,681.47 in pasture account, pasture members are current on board payments. The only things out in the last two months were Dog & Pony show and wormer for September. Fence charger and out house still need to be reimbursed.

Dog & Pony show report: Total costs including insurance, marketing, etc. we did not make any money; we lost a very small amount of money. Need to determine what we're doing for next year and how we want to spend our time.



Old Business:

Dog & Pony Show – group had a discussion around the purpose of the event. Generally, we all agree that the purpose of the event is to conduct community outreach. We can also outreach to other equestrian groups and have an event for them. We need to form a committee to expand the breakfast ride (equestrian outreach) and then a committee for whatever Dog & Pony will become. Ute provided this financial analysis of the Dog & Pony show:
